

Terms and Conditions

1. Costs of Hire

1.1 A period of hire for one day is 24 hours, starting at 9am, unless otherwise agreed. Additional days are calculated pro-rata.

1.2 A deposit of £350 is to be paid before the hire period commences. This sum is refunded in full, on return of the motorcycle and any equipment forming part of the hire contract, in undamaged condition. Any losses or damage to the motorcycle or equipment forming part of the hire contract, will be deducted from this deposit.

1.3 Additional riders may be added to the hire contract, by agreement, and by doing so will be deemed to agree to accept these terms and conditions. A fee of £15 is payable for each additional rider added to a hire contract.

1.4 Helmets, gloves, jackets and boots may be provided at no additional cost, subject to availability. If any such items are provided, they then form part of the hire contract.

1.5 The hirer will normally collect and return the motorcycle and any equipment provided, at our premises. A delivery and collection service is available, by prior arrangement, at an agreed cost.

2 Insurance

2.1 A fully comprehensive insurance policy covers the hirer and the motorcycle during the period of hire. The cost for this insurance is included in the cost for hire. The policy excess, in the event of a claim, is £350 and will be deducted from the deposit.

2.2 People engaged in certain occupations are not covered by our insurance, so please check this with us before making a booking.

2.3 Students and undergraduates under the age of 25 are not covered by the insurance, so are not able to hire one of our motorcycles.

3 Limitations

3.1 Motorcycles can only be hired by riders who conform to the following;-

- a) Aged 19 to 75 years.
- b) Hold a current and valid A2 or unrestricted motorcycle licence. The address shown on the licence must be the hirer's current address. Two additional forms of ID must be shown, to corroborate the address.
- c) If aged between 19 to 22 years must be free from ANY convictions, and free from any accidents other than proven non-fault accidents.
- d) Riders over 22 years who have been disqualified from driving during the last 24 months, or who have currently on their licence three or more convictions during the last 5 years, are not able to hire one of our motorcycles. Spent convictions, covered by the Rehabilitation of Offenders Act 1974 can be disregarded.
- e) UK licence holders must have more than 24 months regular driving experience, as a full licenced driver, of ANY insured vehicle over 250cc.
- f) Non UK licence holders, whose licence is valid in the UK, must have more than 24 months regular driving experience, as a fully licenced driver, of any motor vehicle.

3.2 We are unable to hire motorcycles to persons who have had their insurance declined and/or had their renewal refused or policy cancelled by any Motor Insurer. Or to any person with any criminal convictions. Or to persons who have any physical or mental defect, impairment of sight, hearing, heart, diabetic, epileptic condition or other complaint unless the DVLA have been notified and a licence has been issued and the conditions or restrictions to that licence are adhered to. Or to any person who, whilst driving, have been involved in more than one fault accident during the last 3 years prior to hire.

3.3 Our motorcycles can only be ridden or operated by the Hirer or other permitted persons who have each completed and signed a Motorcycle Hire Declaration form. This form can be downloaded from our website and produced on collection of motorcycle. Or we can complete the form prior to collection, to be signed by each rider on collection.

4.0 Payment

4.1 All costs of hire and deposits must be paid in full before a motorcycle is released.

4.2 To confirm your booking and secure your preferred dates, 20% of cost of hire is required.
